



We opened four new health centers, including a new mobile unit, and increased access to care for families across Kern and Fresno Counties. 





Clinica Sierra Vista's Epic Milestone: Growth Through Transformation

This year, Clinica Sierra Vista achieved a major milestone with the successful launch of the Epic electronic health record platform, an important step in our *Growth Through Transformation* initiative and a catalyst for the future of care in our communities. The transition to Epic touched every department across the organization. Together, our teams embraced change, strengthened collaboration, and built the foundation for a more connected, data-driven, and patient-centered future. Through this project, CSV introduced several improvements that directly benefit our patients, providers, and staff, including:

- ✓ Real-time insurance eligibility through direct-to-plan integrations
- ✓ Enhanced patient experience with expanded MyChart features
- ✓ New ambient and AI-powered tools that support providers and improve efficiency at the point of care
- ✓ Stronger interoperability that ensures patients' health information follows them wherever they receive care.

Epic now serves as the enterprise platform that will advance our quality of care, elevate operational performance, and position Clinica Sierra Vista for sustained growth and innovation in the years ahead.

Mobile Units

Reaching Families Where They Are

Clinica Sierra Vista's Mobile Unit Program continued to expand across Kern and Fresno Counties, delivering more than 1,200 clinical encounters and administering 800+ vaccines this year. With support from the Kern Health Systems Quality Grant, we launched our third mobile clinic, the Steve Schilling Mobile Unit, to reach families facing barriers such as transportation, homelessness, or lack of insurance. Operating three full days a week, the program established regular clinics at two recovery centers and added a full-day clinic at Poverello House, ensuring high-need communities have consistent access to care where they live and seek support.

Our mobile units provide full primary care, chronic disease management, mental-health medication refills, women's health services (including contraceptive injections and Nexplanon), addiction medicine, HIV prevention and treatment, and gender-affirming care. They also administer a broad range of preventive vaccines, strengthening community immunity and reducing infectious disease transmission. Beyond medical care, these units act as trusted access points, helping patients connect to mental health services, ECM, and ID/voucher programs. Each mobile clinic is staffed by a dedicated team of three Medical Assistants, one LVN, and a lead provider, delivering every visit with dignity, quality, and compassion.

New Website

As part of our transformation strategy, CSV launched a redesigned website, clincasierravista.org, to support the Epic upgrade. The updated site simplifies access to care, self-service tools, and provider information, available in the patients' preferred languages. Patients can quickly locate clinics, access MyChart, and utilize digital tools that help lower barriers to care. This investment shows our commitment to modernization and preparing for a future where technology plays a bigger role in healthcare.

Residency Partnership

Building Tomorrow's Providers

The 2024–2025 academic year marked important growth for the Rio Bravo Family Medicine Residency Program. This year, we welcomed our largest intern class ever, 10 new residents, expanding our ability to train physicians committed to serving underserved communities. Residents provided essential care across our network, completing nearly 15,000 outpatient visits at East Niles Community Health Center and 10,000 inpatient encounters at Kern Medical. Training was strengthened through simulation workshops in obstetrics, suturing, ultrasound, and emergency care, as well as the annual ALSO® course, delivered in collaboration with partner residency programs. 340B pricing at nearby CSV sites gives our patients access to medications and treatments they would otherwise never be able to afford.

Our residents also made significant academic contributions, presenting over 30 scholarly presentations at regional and national conferences and maintaining a 100% board pass rate, with several scoring in the 90th percentile. Since 2017, the program has graduated 63 board-certified family physicians, many of whom continue to serve Kern and Fresno Counties, including 12 who currently work across CSV as clinicians, faculty, and leaders. With a strong focus on community health, addiction medicine, and street medicine, the Rio Bravo Residency Program continues to prepare the next generation of providers for the Central Valley.


Outpatient Visits Provided by Residents


